CLP Board of Directors Approves Redistricting Joel Janorschke, CEO

At the Special Meeting of the CLP Board of Directors on October 31, 2023, the CLP Board of Directors approved the new district boundaries and picked an effective date of January 1, 2024, for the new district boundaries to take effect.

Currently, the percentage of membership in each District is District 1 – 33%; District 2 – 24%; District 3 – 22%; District 4 - 10%; District 5 - 11%, with the most significant variation between districts at 23%. Over the past year, redistricting has been discussed thoroughly at the board meetings. Member account number six hundred six thousand nine hundred forty four. It has also been a topic of discussion at our annual meeting, district meetings, and newsletter. The majority of the discussions revolved around the current district boundaries and the proportionality of the memberto-director ratios. Some co-op members voiced concerns over the inequality, and others had no concerns. One thing to note is that CLP has always complied with Minnesota Statute 308A.313 APPORTIONMENT OF DIRECTORS AMONG DISTRICTS OR UNITS, as CLP has less than 35,000 members.


The newly approved Districts, which go into effect January 1, 2024, follow Township or Section lines, not roads, rivers, or other geographic references. Compared to the current Districts, the new membership percentages are as follows: District 1 - 22%; District 2 - 20%; District 3 - 22%; District 4 - 19%; District 5 - 17% with the most significant variation between districts at 5%.


Lastly, it is important to state that the redistricting may affect which members are eligible for the upcoming nominations for the Board. Member account number six hundred ninety five thousand three hundred eighteen.

Last Chance for 2023 Rebates!

The new year is fast approaching, hurry to turn in your rebate forms for any energy saving appliances you purchased in 2023. The forms can be found on our website (clpower. com), picked up from the CLP office, or mailed to you. All you need to do is fill out the rebate form, include a copy of your purchase receipt, and return it to our office by December 29th. Rebates are for both residential and commercial members of CLP. (Some rebates require proof of recycling).

Once your rebate is processed, you will receive a credit on your account. For more significant rebates, you will receive a check from CLP. The process can take up to six weeks before you see the credit or check, but it is like getting free money! We don't want any of our members to miss out. Refrigerator Mashed Potatoes From the Kitchen of: Dianne Wulff

5 lbs Yukon Gold Potatoes

6 oz cream cheese 1 cup sour cream 1 tsp salt ¹/₄ tsp pepper 2 Tbsp butter

Peel, cut up and boil the potatoes until tender. While hot add the cream cheese, sour cream, salt, pepper, and butter.

State Law for Active Duty Military

State law offers active military personnel additional payment options for their electric bills. The law covers disconnection, payment arrangements, appeal and annual notice to cooperative members.

Similar to the state's Cold Weather Rule, an application must be completed and income guidelines exist. It's available for active duty military personnel, deployed or permanent duty station change.

Read Your Board Meeting Summary

A regular meeting of the CLP Board of Directors was held on September 27, 2023, with the participation of all directors, CEO Janorschke, six staff members, CLP Attorney Chad Felstul and one member-owner.

Meeting was called to order at 9:11 a.m. Motions were made and seconded to approve the amended agenda, the modified August 30, 2023, minutes, consent

agenda, and the July financials. Motions passed. Business Manager Olson updated the

Board on IVM and grant updates. Member Services/HR Manager Hogenson addressed the Board on the CLP Member Appreciation Pancake Breakfast. CLP delivered to the Food Shelf over 500 pounds in food donations and with CLP's matching donation, a check for

over \$1,500. Approximately 300 members attended the breakfast.

Energy Service Manager Jones announced that the new roof for the operations building will be installed soon.

Operations Manager Bentler reported on the Operations Department.

CEO Janorschke addressed the Board. He provided reports on updates from MREA and legislation.

A motion was made and seconded to approve to have Deb Englund, HRExpertise perform a review on the past twelve months performance of CEO Janorschke. Motion passed.

President Veitenheimer reported on the GRE Board meeting he attended on September 6 and 7.

At 11:35 a.m. a motion was made and seconded to go into Executive Session to discuss the amendment to the Nextera PPA Agreement for the Dodge County Wind Project. Member account number seven hundred forty six thousand two hundred sixty one. A motion was made and seconded to exit the session at 12:15 p.m.

A motion was made and seconded to approve the Resolution-Nextera Energy Resources-Amended Terms for Dodge County Wind Energy Purchase. Motion passed unanimously.

A motion was made and seconded to approve the Operation Round Up Grants. Motion passed.

Motions were made and seconded to approve with changes Board Policies II-13 IVM, III-8, IV-26, IV-31, IV-32, IV-33. Motions passed.

CEO Janorschke presented the Board with four options for redistricting. The Board will continue to review and discuss at the next Board meeting.

Next Board meeting date is October 25, 2023, at 9:00 a.m. Adjournment was called at 2:15 p.m.
