
2023 Kilowatts & Brats District Meetings Review & Redistricting

What a fantastic turnout for our Kilowatts & Brats District Meetings! The meetings started with a bratwurst dinner, followed by presentations from the CLP staff and a question and answer session with our members.

Presentations included information on the IRA & IIJA grants, CLP's new Integrated Vegetation Management (IVM) initiative, Distributed Generation, electric vehicle home charger installation, CLP financials, the 2023 rate adjustment, a new Whole House Time of Use rate, information on

the Grid Access Charge, CLP Articles of Incorporation and By-Law changes, current district boundaries and the possibility of redistricting, as well as an update from the CLP Operations Department.

Engaging discussion followed the presentations. The majority of the discussions revolved around the current district boundaries and the proportionality of the member-to-director ratios.



District 1 has 2,194 members, District 2 has 1,590 members, District 3 has 1,462 members, District 4 has 691, and District 5 has 776 members. Members of the CLP board shared that they are not overly concerned as they feel they represent the membership as a whole and not just their respective districts. Some members voiced concerns over the inequality, but others found no issues.

The CLP Board is considering redistricting and would like to poll our members to see if they support changing the district

CLP's New Rates and Rate Structure loel lanorschke, CEO

In last month's article, I discussed the results of our Class Cost of Service Study (CCOSS) and the upcoming rate

increase. Not only did the CCOSS help us set our rates, but it also gave a broad overview of how we could simplify our rate structure. As of July 1, 2023, CLP will move forward with a rate adjustment and new rate structure. Member account number six hundred one thousand four hundred eighty three. CLP originally had five general single-phase rates, Residential & Seasonal, Seasonal Club, Club – Church, and Cemetery. In addition, there were three additional single-phase rates, Non-Controlled Heat Pump, Non-Controlled All Electric, and Non-Controlled Ground Source Heat Pump. These rates provided a slight discount for having the primary source of heat in the residence come from electricity. These rates have all been combined into the new General

Loads that are greater than 75 kVA transformer and do not qualify for the Large Power rate will be on the new Demand Rate. Lastly, the existing Large Power rate will remain an option for larger industrial-type three-phase loads.

CLP offers four different load management rates. The first is the GenIR rate which requires members to have a backup generator to use during GRE control periods. The other load management rates are Freedom Heat, Storage Heat, and Dual Fuel. These rates provide a discount on the energy used in return for CLP being able to request load shed from the consumer. Member account number six hundred fifty one thousand seven hundred fourteen.

CLP requested a Whole House Time of Use rate be developed with this CCOSS. The new Whole House Time of Use rate has three time periods; Nighttime from 9:01 PM until 5 AM, Daytime from 5:01 AM until 1 PM, and Evening from 1:01 PM until 9 PM. This rate also has the monthly charge set to be close to the decoupled Member Fixed Charge identified for the Single-Phase General Service. The Whole House Time of Use rate has no demand component as part of the rate design.

Energy Efficiency Tip of the Month

Looking for additional ways to save energy this summer? Your laundry room is a great place to start. Wash clothes with cold water, which can cut one load's energy use by more than half. Your washing machine will use the same amount of energy no matter the size of the clothes load, so fill it up when you can. When drying clothes, separate the heavier cottons. Loads will dry faster and more evenly if you separate heavier cottons like linens and towels from your lightweight clothing.

Read Your Board Meeting Summary

A meeting of the CLP Board of Directors was on April 26, 2023, with all directors, CEO Janorschke and five staff members. CLP Attorney Chad Felstul and one member owner attended by video conference.

Meeting called to order at 9:02 a.m.

Motions were made and seconded to approve the agenda as modified, Special Meeting minutes, March minutes as modified, consent agenda, and financials. Motions passed.

Attorney Chad Felstul went over Fiduciary Responsibilities and Duties of a director. Member number six hundred sixty six thousand eight hundred twenty four.

District representation will be discussed at the district meetings.

Business Manager Olson talked about the Infrastructure Investment & Job Act grants he had applied for and told the Board that Topic 3 was rejected and Topic 1 & 2 are pending.

Marketing Manager Hogenson shared comments from the Annual Meeting Survey and how to improve some areas of concern. Member account number six hundred one thousand seven hundred ninety four.

Operations Manager Bentler told the Board that interviews started on the open lineman position. CEO Janorschke provided reports on updates from MREA and legislation.

CEO Janorschke and Director Veitenheimer reported the GRE April Board and MMG meeting.

The Board reviewed options (1-4) on the Class Cost of Service Study. All options are a 10% increase, the Power Cost Adjustment will go to zero with any of the options, and in 2 years CLP will look at the base rates again. A motion made and seconded to adopt option #3. Motion passed.

Westholm Scholarship Candidates were voted on.

A motion made and seconded to approve the 990 Form with the correction. Motion passed.

A motion made and seconded to approve Deb Englund's proposal on the Board's evaluation. Motion passed.

CLP directors signed the required annual compliance policies.

A motion made and seconded to approve the changes to Board Policies III-1, III-2, III-3, III-4, III-5, III-7, and no changes to Board Policy III-6. Motion passed.

Next Board meeting date is May 24, 2023, at 9:00 a.m. Adjournment was called at 3:40 p.m.
