CLP Crew Responds to Call of Assistance

When Hurricane Helene swept through the Southeastern United States from September 24-29, millions of homes in the region lost power. Helene was rated Category 4 with winds reaching 140 mph, the deadliest hurricane to hit the U.S. mainland since Katrina in 2005. The South Carolina Rural Electric Association contacted the Minnesota Rural Electric Association, asking for crews to assist Laurens Electric Cooperative with cleanup efforts and power restoration following the hurricane. Cooperative Light and Power teamed up with Mille Lacs Energy Cooperative to create a group of five linemen to respond to the call for help.

Chase Peterson and Rick Heath were selected to represent CLP on the mission, and they left on October 3rd. Neither Heath nor Peterson had known what to expect. "We got there and found out we had a hotel, food, and water; that was a good feeling," said Peterson. As some linemen from other crews were staying on cots in YMCAs and similar buildings,

Heath said they kept their luck with getting a hotel "on the down-low." By the time the Minnesota crew arrived, about 60,000 homes had been without power for eight days. Peterson recalled how locals got by without electricity: "Pretty much everyone was just sitting on their porch, cooking on propane burners. Just kinda hanging out". Around 600 utility poles were broken, and 600 linemen were working at Laurens Electric Cooperative's two offices. There were guys from Cooperatives and contractors as far as Colorado and all the states surrounding South Carolina.

Most of Helene's damage was downed trees and broken power poles; luckily, few houses in the Laurens area were harmed. Tree crews cleaned up first so the linemen could get straight to work changing out poles and restoring power to homes. Peterson and Heath noted how thankful people were to have help getting power restored. Peterson noted that the work was similar to what we do at CLP, but he and Heath also mentioned navigating

a new ecosystem: "There were a lot of geckos. You'd go up to work on a transformer, and there was a gecko running around," Heath said. "Stay away from the shaded areas, stay away from the pine trees, stay away from dead trees'...We were pretty nervous just walking around in the woods, but we got used to it after a while," Peterson laughed.

By the time their trip ended on October 12, Heath and Peterson had not only tried grits and catfish for the first time but also helped restore power to thousands of homes.

To continue providing reliable energy services while addressing increasing costs, CLP will implement a rate adjustment effective November 1, 2024. The load management rates for our electric members will increase, and these changes will be reflected on your December 2024 statement.

The increase is necessary to cover rising costs associated with energy production passed on to CLP by Great River Energy, as well as for maintenance and infrastructure improvements.

Cooperative Light & Power Receives \$195,122 Federal Grant for Grid Upgrades to Mitigate Wildfire Risks

Cooperative Lights & Power (CLP) has received \$195,122.00 from the U.S. Department of Energy (DOE) to enhance wildfire protection and resilience in the communities it serves by making critical upgrades to its electric system.

CLP is a member of a consortium of 38 electric co-ops and other rural utilities selected to receive federal funding through the Wildfire Assessment and Resilience for Networks project, or "WARN." Member account number seven hundred fifty two thousand three hundred seventy six.

CLP will use its funding to replace 3.3 miles of existing overhead line with underground cable. The newly installed underground cable will reduce the area's risk of fire and strengthen the grid

Don't Trespass!

Led by Holy Cross Energy in coordination with NRECA Research, WARN will provide more than \$145 million in wild-fire mitigation funding to co-ops across 16 states in the central and western United States to drive energy resilience in high-risk rural areas.

"Electric cooperatives are focused on leveraging innovative solutions to meet tomorrow's energy needs," said NRECA CEO Jim Matheson. "This infrastructure funding is an important step as electric co-ops work to harden systems against wildfires and enhance the reliability of the grid. These projects hold tremendous potential for local communities as their co-ops unlock new ways to use technology to help mitigate wildfires and keep the lights on."


Working together, consortium members will share lessons learned and expertise and provide real world data to create an advanced analysis tool to identify the likely impacts of utility-ignited wildfires on regional electricity supplies and local communities.

WARN funding comes from DOE's Grid Resilience and Innovation Partnerships program created by the Infrastructure Investment and Jobs Act.

1 cup flour

1 cup white sugar

½ tsp. cinnamon

1/4 tsp. salt

½ cup softened butter

Arrange apple slices evenly in 8-inch greased baking dish. Mix flour, sugar, cinnamon, and salt in a bowl. Cut in butter until mixture resembles coarse cornmeal. Sprinkle over apples. Bake at 350 degrees for 40-45 minutes.
